

Sheriff's Report

March 02, 2018

Randolph County Sheriff Mark Nichols reports the following incidents, reports, investigations and arrests.

On February 23rd at 2:15 am, deputies were dispatched to a location on Highway 3, north of Clifton Hill, in reference to a suspicious vehicle in a ditch. Upon arrival, the vehicle was located. The deputy noted that he found the vehicle with the motor running, headlights on and driver's door open. The second deputy searched the area for the driver to no avail. The registration of the vehicle was run. The deputies learned the name of the owner and his address. One deputy remained with the vehicle while the other went to the address of the owner. Contact was made with the owner who did not know that his vehicle was missing. The deputy completed a stolen vehicle report and the vehicle was towed from the scene. The investigation continues.

On February 23rd at 9:45 pm, a deputy was dispatched to the 1800 block of Highway DD in reference to suspicious activity. The complainant reported that they heard 2-gun shots then, 2-vehicles departed the area. The deputy patrolled the area but was unable to locate the vehicles or heard any firearms being discharged.

On February 24th at 7:50 am, deputies were dispatched to the 300 block of North Main Street in Huntsville to provide traffic control at the scene of a possible structure fire. Deputies assisted until it was determined that there was no fire.

On February 24th at 6:14 pm, a deputy was dispatched to a residence in the 3400 block of County Road 2730 in reference to a residential burglar alarm sounding. Upon arrival, the deputy located on door unlocked. When additional units arrived, the house was searched and found to be undisturbed. Contact was made with the homeowner who advised that a friend would be en route to secure the residence.

On February 25th at 12:36 am, a deputy was requested to assist Moberly Police Officers with a fight at a local establishment. The deputy remained on scene until his services were no longer needed.

On February 25th at 4:10 am, a deputy was dispatched to a residence in the 2000 block of County Road 2730 in reference to a domestic disturbance. Upon arrival, the deputy spoke with

the complainant who reported that she and her boyfriend were involved in a verbal argument. The deputy then spoke with the boyfriend who gave the same account of the incident. The boyfriend agreed to spend the night away from the residence. No further action taken.

On February 25th at 6:20 pm, a deputy was contacted by a rural Moberly resident concerning a stolen dog. The complainant advised that he thought he had a possible suspect. The complainant provided a photograph of the animal. The deputy responded to the residence of the possible suspect and viewed her dog. The animal was clearly not a match.

On February 25th at 9:55 pm, a deputy was dispatched to a residence in the 100 block of Powell Street in Jacksonville in reference to a report of suspicious activity. The complainant reported that someone was attempting to enter her residence and shaking the door handle. The deputy responded with the assistance of a Missouri State Highway Patrol Trooper. The officers checked the area but found no one in the area.

On February 26th at 4:30 pm, a deputy received a theft report from a County Road 1217 resident. The complainant reported that he hired a subject to repair his 2010 Ford van. The complainant provided the parts to be replaced on the vehicle. When the complainant retrieved the van due to the subject not repairing it, the complainant noticed that all of the parts were missing. The missing parts consist of a front wheel and tire, 2 sway bar links, 4 – 17” wheels and tires, 2 – front rotors, 1 set of front brake pads, 1 – crank shaft and kit, a drag link, tie rod, 2 – tie rod ends, upper and lower ball joints, an oil pump, a gasket set, a front and rear seal kit, air conditioner parts and a set of keys. The investigation continues.

On February 26th at 6:30 pm, a Huntsville resident was served an order for 96-hour detention, evaluation and treatment. The subject was transported to Biggs Psychiatric Unit in Fulton without incident.

On February 27th at 7:50 am, a deputy was dispatched to a church in rural Jacksonville in reference to a report of property damage. The deputy met with the caretaker of the church who advised that someone broke a window out of the church. The investigation continues.

On February 27th at 2:48 pm, a deputy received a report of a lost or stolen license plate. The plate was entered into MULES.

On February 28th at 5:02 pm, a deputy was dispatched to a location on Huntsville Ave. in reference to a suspicious person. The complainant advised that a male subject was standing in the Highway. The deputy located the subject who advised that he was walking to Moberly. The subject was offered a ride to Moberly but declined.

On February 26th, George Fotovich, 59 of Clifton Hill was served a Randolph County warrant on a class B felony charge of delivery of a controlled substance – minor to purchase or transport and an unclassified felony charge of rape – 1st degree. Bond set at \$75,000 cash only. Fotovich remains in the Randolph County Jail in lieu of the required bond.

On February 26th, James Talor Helm, 37 of Moberly was served a Randolph County warrant for failure to appear on a class B misdemeanor charge of driving while intoxicated. Bond set at \$2,500 cash or surety. Helm was released on his own recognizance by the court.

On February 27th, James Tracy Sullivan, 46 of rural Moberly was served a Randolph County warrant for a probation violation on a class E felony charge of domestic assault – 3rd degree. Bond set at \$10,000 cash or surety. Sullivan remains in the Randolph County Jail in lieu of the required bond.

On February 27th, Devin Sharp, 27 of Fort Scott, Kansas was served a Randolph County warrant on an unclassified felony charge of fugitive from out of State. Bond set at \$10,000 cash only. Sharp remains in the Randolph County Jail in lieu of the required bond.

On February 27th, Marcus Deshaun Tigue, 20 of Columbia was served a Randolph County warrant on a class E felony charge of delivery or manufacture of imitation controlled substance. Bond set at \$5,000 cash or surety. Tigue remains in the Randolph County Jail in lieu of the required bond.

On February 27th, Tracy L. Tullous a/k/a Tray Tullous, 39 of Moberly was served a Randolph County warrant for a probation violation on a class D felony charge of operated a vehicle on highway without a valid license – 3rd and subsequent offense and a class D felony charge of resisting/interfering with arrest for a felony. Bond set at \$25,000 cash only. Tullous remains in the Randolph County Jail in lieu of the required bond.

On February 27th, Christopher Wayne Longdon, 29 of rural Cairo was served a Randolph County warrant on a class C felony charge of manufacture of a controlled substance – except 35 grams or less Marijuana/Synthetic Cannabinoid and a class E felony charge of keeping or maintaining a public nuisance. Bond set at \$20,000 cash or surety. Longdon posted the required bond and released.

On February 28th, Larry Ray Jackson III, 24 of Salisbury was served a Randolph County warrant for failure to appear on a class D misdemeanor charge of stealing – value less than \$150 and no prior stealing offenses. Bond set at \$500 cash or surety. Jackson posted the required bond and released.

On February 28th, Brooke Danielle Belcher 24 of Moberly was served a Randolph County warrant for a probation violation on a class B felony charge of distribute/deliver/manufacture/produce or attempt to or possess with intent to distribute/deliver/manufacture/produce a controlled substance. Bond set at \$7,500 cash or surety. Belcher posted the required bond and released.

On February 28th, Keara Ruthie Jean Shelton, 23 of Madison was served two Randolph County warrants. Warrant one for a probation violation on a class C felony charge of possession of a controlled substance except 35 grams or less of Marijuana and a class C felony charge of keeping or maintaining a public nuisance. Bond set at \$7,500 cash or surety. Warrant two for failure to obey a judge's order on a class C felony charge of possession of a controlled substance except 35 grams or less of Marijuana and a class C felony charge of keeping or maintaining a public nuisance. Bond set at \$25,000 cash only. Shelton remains in the Randolph County Jail in lieu of the required bond.

On March 01st, Ashley Nicole Kaibel, 33 of Brashear was served a Randolph County warrant on a class A misdemeanor charge of possession of Marijuana/Synthetic Cannabinoid of 11 to 35 grams, a class B misdemeanor charge of driving while intoxicated and a class A misdemeanor charge of unlawful possession of drug paraphernalia – prior drug offenses. Bond set at \$2,500 cash or surety. Kaibel posted the required bond and released.

On March 02nd, Ashley Lynn Henderson, 29 of Moberly was served a Randolph County warrant for failure to appear on three class A misdemeanor charges of stealing. Bond set at \$500 cash only. Henderson remains in the Randolph County Jail in lieu of the required bond.
