

Sheriff's Report

June 01, 2018

Randolph County Sheriff Mark Nichols reports the following incidents, reports, investigations and arrests.

On May 25th, a deputy was dispatched to a residence in the 500 block of Prairie Lane in Huntsville in reference to a domestic disturbance. Upon arrival, the deputy met with both parties who advised that they had been involved in a verbal argument. The male subject agreed to leave the residence for the evening. No further action taken.

On May 25th, a Huntsville resident reported a domestic assault to a deputy that occurred in Higbee. The complainant reported that her boyfriend assaulted her by dragging her by the hair and striking her in the face numerous times. The victim had injuries consistent with her claim. The deputy has been attempting to locate the suspect for questioning. The report has been forwarded to the Randolph County Prosecuting Attorney for review and formal action.

On May 26th, while traveling on Highway 63, a deputy observed a vehicle traveling on County Road 1365, approaching Highway 63. The deputy attempted to catch the vehicle to initiate a traffic stop. The vehicle eluded the deputy. Later the deputy received a call concerning a suspicious vehicle, in the same area. The deputy met with the complainant who provided the deputy with a description of the driver and vehicle. The deputy located the vehicle in Moberly and identified it as the vehicle that eluded him. The driver was contacted, arrested and transported to the Randolph County Jail.

On May 26th, a deputy was dispatched to the intersection on Highways AA and B in reference to cattle on or near the roadway. The deputy patrolled the area but did not observe any cattle out of confinement.

On May 26th, a deputy received a suspicious incident report. The complainant reported that she had listed items to sell on Craig's List, and was contacted by a potential buyer. The subject sent the complainant a check for a much larger amount than what was asked for the items. The check was determined to be counterfeit and that the complainant was attempted to be scammed. The check was seized. The investigation continues.

On May 26th, a deputy was advised to be on the lookout for a dark colored Lincoln passenger vehicle, that was a suspect vehicle in thefts from Moberly and Macon. A short time later, the

deputy observed a vehicle matching the description given. The deputy initiated a traffic stop and identified the occupants. The deputy located the stolen items. One suspect was turned over to the authority of Moberly Police and a second suspect was turned over to Macon Police.

On May 26th, a deputy was dispatched to County Road 2680 in reference to cattle on or near the roadway. Upon arrival, the deputy located two cows. As the deputy exited his vehicle, the cows ran in a wooded area. An individual stopped and informed the deputy of the name of the owner of the cattle. The deputy attempted to contact the owner to no avail.

On May 26th, a deputy was dispatched to a residence in the 600 block of Harlan Street in Clifton Hill in reference to keeping the peace while one party retrieved personal property from the residence. The property was gathered without incident. No further action taken.

On May 27th, a deputy was dispatched to a location on Highway 63 in reference to a wrong-way driver. The deputy patrolled the Highway without locating any vehicles traveling in the wrong lanes.

On May 27th, a deputy received a theft report from a Higbee resident. The complainant reported that someone removed the license from his 2005 Ford truck. The plates have been entered into MULES.

On May 29th, a deputy was dispatched to a location on Highway 63 south of Clark in reference to a motor vehicle accident. The deputy patrolled the area without observing any vehicles that been in an accident.

On May 29th, a deputy was dispatched to a residence on County Road 2210 in reference to a bull that was on the property. The complainant reported that he does not own any cattle. The owner of the bull was located and advised where his bull was. The owner immediately retrieved the bull and secured it in his pasture.

On May 29th, a deputy was dispatched to a location on Highway 63, near County Road 2770 in reference to assisting the Missouri State Highway Patrol with traffic control at the scene of a motor vehicle accident. The deputy remained on scene until his services were no longer needed.

On May 30th, a deputy was dispatched to a residence in the 100 block of W. Clay Street in Huntsville in reference to a report of suspicious activity. The complainant reported that he heard someone walking on the roof of his residence. When the complainant yelled at the subject, the subject fled the area. The deputy patrolled the area without locating anyone.

On May 30th, a deputy was dispatched to Highway 63 in reference to a wrong-way driver. The deputy patrolled from Highway 24 to the Macon County Line without locating any vehicles traveling in the wrong lanes.

On May 30th a deputy was dispatched to a residence on County Road 1205 in reference to a burglary. The complainant reported that someone forced entry into the residence and ransacked the home. The investigation continues.

On May 24th, Kayla Louise Wester of rural Moberly was served a Randolph County warrant for a probation violation on a class C felony charge of burglary – 2nd degree, a class C felony charge of theft/stealing property or services of \$500 or more but less than \$25,000 and a class D felony charge of failure to appear – felony. Bond set at \$20,000 cash only. Wester remains in the Randolph County Jail in lieu of the required bond.

On May 24th, Gregory Alex Tolson of Moberly was served a Randolph County warrant on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class A misdemeanor charge of unlawful possession of drug paraphernalia. Bond set at \$7,500 cash or surety. Tolson remains in the Randolph County Jail in lieu of the required bond.

On May 24th, Rachel Lynn Sprague of Shelbyville was served a Randolph County warrant for failure to appear on a class A misdemeanor charge of leaving the scene of a motor vehicle accident. Bond set at \$2,000 cash only. Sprague remains in the Randolph County Jail in lieu of the required bond.

On May 24th, Chyanne Marie Kitson of rural Moberly was served a Randolph County warrant for failure to appear on a class D misdemeanor charge of driving while revoked or suspended – 1st offense. Bond set at \$200 cash only. Kitson remains incarcerated.

On May 25th, Daniel Gaines Bowden of Moberly was served two Randolph County warrants. Warrant one for failure to obey a judge's order on a class E felony charge of driving while revoked/suspended. Bond set at \$100,000 cash only. Warrant two for failure to obey a judge's order on a class E felony charge of driving while revoked/suspended. Bond set at \$100,000 cash only. Bowden remains in the Randolph County Jail in lieu of the required bond.

On May 26th, Jason M. Gray of rural Moberly was served a Randolph County warrant for a probation violation on a class A misdemeanor charge of passing bad checks – less than \$500. Bond set at \$200 cash only. Gray remains in the Randolph County Jail in lieu of the required bond.

On May 29th, Michael James Bass of rural Clark was served a Randolph County warrant for failure to obey a judge's order on three class D felony charges of forgery. Bond set at \$25,000 cash or surety. Bass remains incarcerated.

On May 29th, Emily Marie Gravso of rural Moberly was served a Randolph County warrant for failure to appear on an ordinance violation of leaving the scene of a motor vehicle accident. Bond set at \$250 cash only. Gravso posted the required bond and released.

On May 29th, Melissa Diane Logan of Moberly was served a Randolph County warrant for failure to appear on a class B misdemeanor charge of driving while intoxicated. Bond set at \$300 cash only. Logan posted the required bond and released.

On May 29th, Samuel Vernon Cockrell of Moberly was served a Randolph County on a class E felony charge of non-support, total arrears in excess of 12 monthly payments due under order of support. Bond set at \$3,500 cash only. Cockrell remains in the Randolph County Jail in lieu of the required bond.

On May 29th, Andrew Ryan Derboven of Huntsville was served a Randolph County warrant on a class C felony charge of delivery of a controlled substance except 35 grams or less of Marijuana or Synthetic Cannabinoid, a class D misdemeanor charge of possession of Marijuana/Synthetic Cannabinoid of 10 grams or less and a class E felony charge of unlawful possession of drug paraphernalia – amphetamine or methamphetamine. Bond set at \$10,000 cash or surety. Derboven remains in the Randolph County Jail in lieu of the required bond.

On May 30th, Nathan Ryan Tuggle of Moberly was served three Randolph County warrants. Warrant one on a class E felony charge of driving while revoked/suspended. Bond set at \$5,000. Warrant two for failure to obey a judge's order on a class D felony charge of possession of a controlled substance except 35 grams or less of Marijuana/Synthetic Cannabinoid and a class E felony charge of resisting/interfering with arrest for a felony. Bond set at \$25,000. Warrant three for failure to obey a judge's order on a class E felony charge of driving while revoked/suspended. Bond set at \$10,000 cash or surety. Tuggle remains in the Randolph County Jail in lieu of the required bond.

On May 30th, Cameron Blake Turner of Moberly was served a Randolph County warrant on a class A misdemeanor charge of resisting or interfering with arrest/detention/stop and a class D misdemeanor charge of minor visibly intoxicated/blood alcohol content more than .02% - 1st offense. Bond set at \$3,500 cash or surety. Turner posted the required bond and released.

On May 30th, Jimmie Wesley Woods of Armstrong was served a Randolph County warrant on a class A felony charge of robbery – 1st degree. Bond set at \$4,500. Woods remains incarcerated.

On May 30th, George Wake Bell II of Moberly was served a Randolph County warrant on a class E felony charge of domestic assault – 4th degree – 3rd offense. Bond set at \$5,000 cash or surety. Bell posted the required bond and released.

On May 31st, Floyd Ray Snow of Moberly was served a Randolph County warrant for failure to obey a judge's order on a class C felony charge of driving while intoxicated – chronic offender and a class E felony charge of driving while revoked/suspended. Bond set at \$20,000 cash only. Snow remains in the Randolph County Jail in lieu of the required bond.
